# Privacy Policy - Rotaract European Meeting Utrecht 2026

#### 1. Introduction

This Privacy Policy explains how Stichting Rotaract European Meeting Utrecht 2026 ("we", "us", or "the Foundation") collects, uses, shares, and protects your personal data through our website and in connection with event registration, ticketing, and participation for the Rotaract European Meeting Utrecht 2026 (REM Utrecht 2026), taking place in Utrecht, The Netherlands, from 29 January to 1 February 2026.

We handle your personal data in accordance with the General Data Protection Regulation (EU) 2016/679 (GDPR) and the Dutch Implementation Act (Uitvoeringswet AVG).

- Whether you require a visa to enter the Netherlands
- Preferred roommate (if applicable)
- Dietary restrictions or food allergies
- · Accessibility or special needs requirements
- Any additional information you wish to share with the organizers
- Whether you require an invoice for your ticket purchase

## E. Payment and Ticketing Data

- Ticket type and purchase details

We collect your personal data:

- When you fill in the registration or ticket purchase form on our website or ticketing platform.
- When you communicate with us by email, social media, or other channels.
- When we receive information from ERIC to verify membership or participation eligibility.

We will not use your personal data for purposes other than those listed above.

# 6. Sharing of Personal Data

Your data may be shared with:

- ERIC (European Rotaract Information Centre) for multiple distinct purposes, including:
  - o Verification of Rotaract or Rotary affiliation;
  - o Financial administration by the us and ERIC; and
  - Other legitimate interests pursued by ERIC, such as enabling effective communication within the Rotaract network.
- Ticketing platform provider to process registrations and payments.
- Accommodation and catering providers only for logistical and dietary requirements.
- Event volunteers or organizing committees under strict confidentiality.
- Legal authorities when required by Dutch or EU law.

We do not sell, rent, or commercially share your data with third parties.

#### 7. International Transfers

All data is primarily processed within the European Economic Area (EEA). If we use service providers outside the EEA, we ensure appropriate safeguards (e.g., EU Standard Contractual Clauses) to maintain GDPR compliance.

### 8. Data Retention

We retain personal data only for as long as necessary for the purposes listed:

Data Type	Retention Period
Registration and ticket data	Up to 6 months after event conclusion
Financial and invoicing data	7 years (as required by Dutch law)
Photos and media	Until consent is withdrawn
Communication and logistical data	Up to 6 months after event conclusion

You have the right to:

- Rectify inaccurate data
- Request deletion ("right to be forgotten")
- · Restrict processing
- · Object to processing
- Receive your data in a portable format
- · Withdraw consent at any time
